Paul has spent 23 years as a prosecutor in the Contra Costa District Attorney's office. *Lawrence S. Strauss:*

As a small business owner for over twenty-three years, lawyer, and former Deputy Prosecutor (Hawaii), I am seeking to become District Attorney of Contra Costa County because the safety of the public is at extreme risk due to the current inefficient and inept management. Our police officers are doing their jobs and catching the criminals. They issue citations and forward their reports to the DA's office for prosecution. When the defendant appears on the stated court date, there is no case filed. He is told to contact the District Attorney's Office to check the status of the case, or the court will send a notice to appear in the mail. Do you honestly believe that a criminal is going to follow up with the DA's Office regarding potential charges against him? Eleven months after the arrest, a complaint is filed and sent in the mail. A bench warrant is issued, and after eighteen months from the date of the arrest, the person is finally brought to the beginning of justice! What do you think that drunk driver, thief, or drug addict has been doing in the eighteen months that have gone by due to the untimeliness in filing complaints by the DA's office?

The DA's Office is wasting time and money on unnecessary expenditures. I represent inmates at Lifer Parole Hearings in the state prisons all over California. I am required to drive three to four hours and personally appear at the hearings. The DA's Office is allowed to utilize telephone and video conferencing. Instead, the Deputy District Attorney ("DDA") is traveling by airline and/or renting a car, paying for gasoline, staying at fancy hotels, and eating expensive meals all at taxpayer expense! Also, the hearings sometimes start three hours late, and he is being compensated for the waiting time. As DA, I am going to curtail this abusive practice. Only telephone and video conferencing will be permitted. If there is a delay in the hearing, the DDA will be able to work on other tasks such as promptly filing complaints.

The above anecdotes are only two examples of the pervasive incompetence of the current administration. There are other areas of concern such as the unnecessary court congestion due to not promptly relaying dispositional offers on cases and the lack of use of technology such as utilizing paper files instead of a computerized system that would assist in the filing, distribution, and organization of cases. Also, there is no full-time employee whose job duty would be applying for available grant funding. The state and the federal government provide funding to hire additional attorneys and support staff in different legal areas; yet, the current DA's Office is not aggressively pursuing that strategy.

I appreciate the opportunity to be of service to the people of our county. I look forward to your

support to change the systemic failures of the DA's Office.
